I Rudra Prasad kundu, son of Sri. ranjan Kundu resident of Dalkhola, Deshbandhupara, P.O & P.s. dalkhola, Dist Uttar Dinajpur C/O. Laxmi kanta Biswas, Kawakhali bazaar, P.O Sushruta Nagar, P.s Matigara, Dist-Darjeeling, would like to inform you that on 17.04.2023 at about 10.30 pm, upon on invitation, I went to my neighbour house to attend a blessing ceremony (ashirvad). At about 12.00 am one of our senior neighbour of my village namely Goutam Roy, son of Thalen Roy, r/o. kawakhali bazaar, P.O Sushruta nagar, P.s Matigara, Dist Darjeeling asked me one cigarette and on refusal he demanded money from me instead. Again when I refused to his demand he became furious and started to assault me with fist and blows and also used slang and offensive language against me. In order to save myself I tried to escape from that place but suddenly he hit me with a sharp weapon at the backside of my neck in an attempt to kill me and as a result I fell on the road and became senseless. Two of my friend Ranjan Biswas, S/o Arjun Biswas and Nabin Biswas S/o Gopal Biswas of kawakhali called my family members and friends and after arriving at the spot they all admitted me to N.B.M.C&H. Now 9 am under treatment. said Goutam stole my phone and wallet when I was senseless which I later recovered by the help of our panchayat. I therefore request you to kindly take necessary legal steps against said Goutam roy and please save me from his hands.
