Sir,

- I, Smt. Kalpana Thapa, wife of Mahendra Thapa, resident at 43 Nichu Bhanu Nagar, Kabi Agam Singh Road, Sevoke Road, P.O. sevoke road P.S. Bhaktinagar, District Jalpaiguri, at present residing at Middle palash, VTC Champasari P.O. Champasari P.S. Pradhan Nagar, District Darjeeling, do hereby lodging this F.I.R., which is as follows:-
- 1. That on 1986 my marriage was solemnised with one Mahendra Thapa, Son of Late Daising Thapa, Business by Occupation, resident of Middle palash, VTC Champasari P.O. Champasari P.S. Pradhan Nagar, District Darjeeling, at my paternal house, mentioned above i.e. Samsing.
- 2. That at the time of my marriage as per the demand of my husband my parents gave a Sum of Rs. 50,000/- (Rupees fifty Thousand only) to my husband as dowry.
- 3. That after my marriage I started my nuptial life with my husband at House 43 Nichu Bhanu Nagar, Kabi Agam Singh Road, Sevoke Road, P.O. sevoke road P.S. Bhaktinagar, District Jalpaiguri, and out of the said wedlock two children has been born named by Bivor Thapa & Bivek Thapa aged 37 & 35 respectively and now they are living separately.
- 4. That in the year 2022 during the festive season of Durga Puja my husband voluntarily left our matrimonial home without informing me or our children, we tried to contact him and searched for him everywhere but subsequently after a few days I saw my husband roaming around during Durga Puja with one women and after enquiring about the same I came to know that the women was Astami Rana daughter of Rajendra Rana resident of samsing M.B.P Line Tea Estate P.O & P.S Mateli District: Jalpaiguri and subsequently we also came to know that my husband had married the same women named by Astami Rana and together they had a daughter named by Ashmita Thapa and they were staying together as husband and wife at a rented house at Gurung Basti.
- 5. That After the said incident I was mentally disturbed and subsequently I left my matrimonial home and started living with my eldest son at Khola Chand Fapri, P.S: Bhaktinagar, District: Jalpaiguri and after a lapse of 6 months my in-laws along with my family members called a N.G.O named by Global Human Rights Peace Foundation

to sort our differences subsequently our differences were resolved and I along with my husband returned to my matrimonial home and resumed our matrimonial life.

- 6. That On 24-03-2023 my husband left for our shop which is located at Champasari Radhika Bawan at around 10.00 Am as he usually does the same but that day he did not return home from the shop I tried to contact him but to no avail as he had switched off his mobile phone and after that I contacted several of our family members to know about his whereabouts but to no avail, subsequently on 2-04-2023 finding no other alternative I went to the shop to check whether the shop had been opened but the landlord informed us that he had shifted the shop to a new place and he had also shifted all the materials from the shop.
- 7. That after a few days I found that my husband has also taken away the entire papers relating to our house and land and my husband voluntarily abandons me, and started to live with Astami Rana at Samsing M.B.P Line Tea Estate P.O & P.S Mateli District: Jalpaiguri, which tantamount to mental cruelty upon me and till that date to up till now he is not maintaining me, It is not out of place to mention here that being an Indian lady I tried to contact my husband several times to patch up the matter but all are in vain.

Being helpless, I am praying before you to take appropriate legal action against my husband and the said lady so that I can get proper justice from the administration.
