(Paddler of Toto (E-rickshaw), without number plate, Blue Colour). Along with his Toto under seizer, I SI. Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 20.04.2023 I along with TC-Jyotirmoy Sikdar and CV-507 Sujan Shil, while performing traffic regulation duty at NH-10, near Champasari More found that, the above noted person was plying his Toto (E-rickshaw), as noted above on NH-10 by violating Govt.
