Sir,

I am Shankar Pradhan, S/O- Sri C.B Pradhan, currently residing at Sukna Part I, P.O. Sukna, P.S. Kurseong, Dist- Darjeeling, Pin- 734009 hereby to inform you that I am a Ex Service man (Retired B.S.F), that one Raju Lama and Smt Manju Khati Lama of Batala Champasari, P.O — Champasari, P.S-Pradhan Nagar, Dist- Darjeeling had received Rs 1,00,000 (Rupees One Lakh) from me and my brother-in-law Sri Prem Tamang resident of Sonada Prasanti Gram, Ex Service man (Retired Army) for recruitment as Security Guard in Abord. Whereas I had given Rs 80,000 (Rupees Eighty Thousand), and Prem Tamang had given Rs 20,000 (Rupees Twenty Thousand) to Raju Lama. And Raju Lama had promise us that they will handover our appointment letter with visa within month of February 2023, But they Failed to handover an appointment within a Stipulated Period. After the Stipulated Period I asked Raju Lama And his wife Manju Khati for return the total amount of Rs 1,00,000 (Rupees One Lakh). And therefore they had refunded me Rs 50,000 (Rupees Fifty Thousand) only (Rs 30,000 (Rupees Thirty Thousand) only by online Transfer and Rs 20,000 (Rupees Twenty Thousand) only by cash)and they had promised to return the rest amount Rs 50,000 (Rupees Fifty Thousand) within the 20th April 2023.

Thus today 20-04-2023 I went to Raju Lama house to collect the rest security money as I searched therein house they started talking in loud voice and also hit me with bow and sharp weapon and thus somehow I rescue myself.

They had cheated us and also threatening that they will kill if we report this matter to the police. And also threated me that they will tag us in fake case. As your Kind information they are very dangerous people.

Therefore This is my humble submission to lodge specific complaint against them for cheating, breach of trust and inflicting mental torture so that we can live in peace and harmony.

I shall be obliged if you kindly take action.
