I, Devika Thami, wife of Mandeep Tamang (PH 801370-3620) residing at Queens Residency, Flat No: 3B Opposite Greenwood Hotel Satbari, Sukna P.S - Pradhan Nagar, P.O - Satbari, informing you that I got married with Mandeep Tamang on 8th December, 2015 as per Hindu Customs and Rights. Soon after marriage we started to live together as a husband and wife in the residence which we have bought together in 2018. He is mentally harassing me since very long time, even though I have adjusted and wanted to stay with him but on 4th March, 2023 he has taken the decision of divorce and presently my husband is residing separately from me and from last two months he has not given me a single Penny but he is paying 20,000/- monthly to another woman which I got this information from his bank statement. We have a flat in loan for 21 years and need to pay the 15000/- EMI per month which is not possible for me to pay because I earned 10000/- 15000 per month in a private company so it becomes very difficult for me to survive. Need your help urgently because I don't have any support from anyone. I am going through a mental trauma apart from this residence I have no place to live.

Therefore, you are requested to investigate in this matter and take immediate steps regarding this matter.
