Sir,

With due respect I S.I Chetan Dangal of Pradhan Nagar Police Station, Siliguri Metropolitan Police do here by lodge this complainant against (1) Bikash Rastogi (M/28) s/o Sankar Prasad of Saman Nagar Autostand, P.S Pradhan Nagar, Dist Darjeeling (2) Dipak Shaw (M/40) s/o Kapil Shaw of Saman Nagar Autostand, P.S Pradhan Nagar, Dist Darjeeling and 30/40 others to the effect that, today 25.4.2023 at 16.40 hrs I along with S.I Rabindranath Sarkar, SI Jimut Kanti Roy, S.I Atanu Majumder, PSI Bijay Sarkar, PSI Biswadeb Barman, ASI Manoj Kumar Roy, ASI Amar Raj Subba, ASI Jagannath Roy, ASI Biplab Kumar Das, C/207 Niladri Sarkar, C/473 Amrita Sarkar, C/1169 Prasanjit Barman, C/762 Md. Mojibar Rahaman, LC/338 Subha Rai, LC/1274 Susmita Mothey, LC/1263 Sujata Thapa, were detail for Law and Order duty in respect of a Sabitri Sha murder case at Champasari, under Pradhan Nagar P.S vide L/O CC No. 27/23 Dated 25.04.2023.

While performing L/O Duty the above noted 02 (two) persons along with 30/40 others have gathered there and have blocked champasari - devidanga main road near Champasari more. To maintain law and order and free flow of Traffic I along with other on duty police personnel requested them not to took law in their hands and allow free flow of traffic but, at that time they became agitated and started to push the police personnel present there and caused obstruction to police personnel in discharge of the lawful duty, abuse police personnel in filthy and abusive languages. Further they blocked the champasari - devidanga main road as result all the vehicular traffic was jammed by their activities. Due to the blockade caused by those miscreants all the vehicular traffic was jammed for approx 1 hour which causes inconvenience and harassments to the public in general.

Thereafter I arrest two persons viz: (1) Bikash Rastogi (M/28) s/o Sankar Prasad of Saman Nagar Autostand, P.S Pradhan Nagar, Dist Darjeeling and (2) Dipak Shaw (M/40) s/o Kapil Shaw of Saman Nagar Autostand, P.S Pradhan Nagar, Dist Darjeeling u/s 41 Cr.P.C after issuing arrest memo and intimating the grounds of arrest,

Further it came to light that out of 30/40 persons one person name was Ravi Mandal (M/19) s/o Sankar Mandal of Gurung Busty, Upper Road, Dalbir Road, P.S Pradhan Nagar, Dist Darjeeling was also present there and caused obstruction to police personnel in discharge of the lawful duty, abuse police personnel in filthy and abusive languages, and also blocked public road causing inconvenience to general public but he managed to flew away during hot chase.

Therefore, I pray before your good self that a specific case under proper section of law may kindly initiated and also may cause for its investigation.
