

Sub: Report of side on collision of my car bearing
Reg. No. NB74AN6785 by a Red Volvo Wagon Polo bearing
Reg. No. NB74Z7039.

Dear Sir,

This is to report an accident which happened near
Daijeeling more yesterday at around 7:00 PM, that's 21/04/2023
right off the commissionerate in the National Highway.
A red Volvo wagon Polo bearing No. NB74Z7039 came from
the opposite side which was the wrong way and collided
into my car that is Maruti Baleno, which turned upside
down and caused me severe head injury. I have suffered
serious injury on my head and was hospitalised at
Neotia Hospital, Matigara, on 21/04/23 and was under-
observation till 22/04/2023. I had to undergo investigations
for the injuries suffered by me and I was given nine
stitches. I have been advised complete bed rest for the
next few days as there was massive bleeding and injuries
to my body. There were two, three people in the red car
and they are guilty of rash negligent that could have
caused my death.

I want the police to investigate into the matter
and take appropriate strict action against the person
driving the red car, at the earliest as I have suffered
severe bodily injury. My car is completely damaged
