Sir,

With due respect, I LSI Subarna Routh of Matigara P.S SPC would like to lodge this written complaint against (i) Sikha Maitra, President of Bharatiya Janata Mahila Morcha, Darjeeling District Committee, (ii) Soma Majumder, Secretary of Bharatiya Janata Mahila Morcha, Darjeeling District Committee, (iii) Reshmi Sharma, General Secretary, Darjeeling District Committee Bharatiya Janata Party and 55/60 others to the effect that today (22.04.23) information was received that the BJP party will organise a protest demonstration at the office of the Commissioner of Police Siliguri Police Commissionerate, without any prior intimation. This refers to Matigara PS GDE No.1197 Dtd- 22.04.2023. Accordingly, LSI Subarna Routh, SI Chabilal Sinha, S P.K. Sen Sarkar, ASI Prabir Roy, ASI Kanak Das, L/C 1315 Kabita Ekka, L/C 1251 Yankila Bhutia, L/C 1316 Chandana Paul, C/585 Hitendra Nath Roy, C/523 Sanjit Kundu, C/227 Samiran Sarkar, C/405 Samar Halder, C/1051 Dipankar Roy Basunia, accompanied by officers and force vide MCC no.372.dt 22.04.2023 left for the office of the CP at Mallaguri. Superiors were also informed about the input.

On reaching the main gate of the office of the CP, Siliguri SPC, at around 16:25 hrs, more reinforcement under the supervision of Shri. Asish P. Subba ACP (West) SPC and Shri. Suraj Thakuri ACP(HQ) SPC, RI, MTO and others had also been deployed at the gate from the HQ vide RI L/O CC No.536 (04)/2023, Dated- 22.04.2023, and winners team of SPC detailed for the said L/O duty vide Org No. 3290/SB/SPC, dated- 22.04.2023 under the supervision of ACP (HQ), SPC

At 17:35 hours, 55/60 supporters of the BJP Mahila Morcha under the leadership of above noted Sikha Maitra, Soma Majumder, Reshmi Sharma, approach the main gate in an agitated mood shouting slogans against the police over the issue of the alleged rape and murder of a student under Kaliaganj PS, Uttar Dinajpur. Since the agitated mob was in an aggressive mood, lady police personnel were deployed at the front of the main gate and guardrails placed.

The mob led by the above noted accused persons stormed at the police barricade and tried to enter inside forcibly. Supervisory officers requested them not to indulge in any kind of unruly activity and that the police were ready to hear their grievances. None of them unruly mob paid any heed to the repeated requests made by the police. They started to assault the Police on duty and the situation became chaotic. The above accused persons instructed the mob to break through the police barricade and in this melee; they damaged the collapsible guard-rail. The police still requested them to refrain from their unruly violent activities but fell into deaf ears. They became more and more violent and continued assaulting the police. In this assault namely LASI Pabitra Singh, L/C 1251 Yankila Bhutia, L/C 1287 Pranisha Thapa, L/C 1384 Soneka Barman, LCV Laxmi Roy, sustained severe injuries and bites on their person.

The Police displayed utmost restraint did not resort to any form of force on the mob or any other sort of use of force.

The Police convinced and took away the accused Sikha Maitra from the spot in order to calm her down and bring the situation under control. After continuous pursuance the violent mob was brought under control and they left the spot along with their leaders as named above.

Under the above circumstances, I pray before your good office that a specific case under proper section of law may kindly be initiated against above noted (i) Sikha Maitra, President of Bharatiya Janata Mahila Morcha, Darjeeling District Committee, (ii) Soma Majumder, Secretary of Bharatiya Janata Mahila Morcha, Darjeeling District Committee, (iii) Reshmi Sharma, General Secretary, Darjeeling District Committee Bharatiya Janata Party and 55/60 others and arrange for its investigation.
