Plot No.- 180- area measuring 46.5 decimals, I.e. situated in Mouza - KAWAKHARI, JL. No. 72, Pargana- Patharghata, Touzi No. 91 within P.S.- Matigara, Dist- Darjeeling, West Bengal.
