In producing herewith two(02) loaded seized Truck (Dumper) having registration No. WB73D 9614 and WB73D 9469 with loaded with River bed Sands.

I, SI Uday Shankar Mandol of Panitanki TOP under Siliguri P.S/SPC lodge a written complaint against the above noted truck (Dumper) having registration No. WB73D 9614 and WB73D 9469 to the effect that today i.e. 30.04.2023 at about 01:05 hrs while performing mobile van duty at Pranami Mandir Road under PS Siliguri and found that two (02) truck (Dumper) having Registration No. WB73D 9614 and WB73D 9469 ware loaded with illegal river bed Sands coming from Sevok Road, Bhaktinagar side and going toward Pranami Mandir road, Siliguri. Accordingly myself along with force managed to apprehend the said trucks but that time drivers of the trucks stop the vehicle and fleeing away from the spot and on checking the vehicles and found the trucks loaded with sands of said loaded without valid documents relating to the loaded sands in the trucks. Hence there was reasons to believe that the drivers and the owner of the trucks jointly had procured the vehicles along with its loaded materials illegally and transporting the same for their illegal gain. On further the drivers with knowledge with the owner of the trucks in association with others of several Mahananda river had procured the River bed materials. sands illegally from and carrying/transporting the same to Siliguri side for their wrongful gain without any valid documents.

Under the circumstances, I seized the two (02)Trucks (Dumper) bearing Reg. no- WB73D 9614 and WB73D 9469 along with loaded sands under proper seizure list. The whole process of seizure took place in between 01:45hrs to 02:25hrs.

Under the above. I pray before your kind end to start a case against the drivers of the seized Trucks (Dumper) bearing Reg. no- WB73D 9614 and WB73D 9469 with his owner of the seized vehicle under proper section of law and caused its investigation.
