knowledge and thereafter knowing this when I tried to call or reach their contact numbers, the same were unreachable. And subsequently, when I tried to contact Sri Raj Kumar Acharya on his mobile number, surprisingly his mobile number was also unreachable and the same has left me under utter

It is pertinent to mention here that the lady Smt. Manpreet Kaur together with her husband in connivance with Sri Raj Kumar Acharya had cooked up such fake story in order to make illegal gains causing great monetary loss and damage to me and at the same time they have not only committed breach of trust but they have also cheated me with ill-motive.
