Subject: Fraudulent Transaction on Google Pay

I Srijana Gazmer, beg to say that myself a resident of Ambadhura, Salbari, Siliguri, have an account in my name holding account number 20178183253 in State Bank of India in Salbari, Methibari. From my account, an amount of Rs. 1,90,000 (One lakh ninety thousand) has been credited to Sanjay Sarkar's Google pay phone number i.e. 7715928400 bearing the UPI ID name sanjaysarkar1995ghonja@okaxis by promising the fraud job opportunity.

I have been contacted by Sanjay Sarkar claiming to offer a job in Qatar, in the company named "Mom's Kitchen", and sent us fake documentation. The contact was made through **WhatsApp** in +974 66473052 and the individual promised to provide the job if we pay him.

The documentation he provided looks very real, but upon closer inspection, it is clear that it is fraudulent. I have reported this incident to the bank authority, and they suggested us to visit the cybercrime branch and register a FIR.

There are altogether 7 different transactions made by me. The transaction details are mentioned below.
