With due regards, I, SMT. DIPTI PODDER (SARKAR), Wife of Sri Subrata Podder @ Partha, Daughter of Sri Bishnupada Sarkar, Presently residing at M.M. Dutta Road, Deshbandhu Para, Near Loknath Bekary, Ward No. 30 of S.M.C., Siliguri, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin: 734004, would like to lodge this written complaint before your good office to the effect that Subrata Podder @ Partha, Son of Late Niranjan Podder, of M.M. Dutta Road, Deshbandhu Para, Near Loknath Bekary, Ward No. 30 of S.M.C., Siliguri, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin: 734004 is my legally married husband and our marriage was solemnized on 14.07.2004 according to Hindu Rites and Customs . After my marriage, my husband brought me at my matrimonial house as mentioned above where we started to lead our conjugal life as husband and wife and out of our lawful wedlock, one female child was born on 17.04.2005 whose name is Miss. Debangi Podder.

Since the date of our marriage, my husband and in laws members have started mental and physical torture upon me on the ground of dissatisfaction of stridhan articles which were given by my parents at the time of my marriage. My father-in-law expired prior to our marriage and the property of my matrimonial house belongs in the name of my father-inlaw and after our marriage, the property which stands in the name of my father-in-law, divided in between my husband and my three brother-inlaws and at the time of registration of the said property, my husband asked me to bring a sum of Rs. 50,000/- only from my parents for the purpose of registration of the said property in the name of my husband and as per his demand, I informed the same to my father and accordingly my father has paid and delivered the said amount to my husband considering my future conjugal life.

My mother-in-law Smt. Maya Podder in conspiracy with my husband and brother-in-laws namely Sri Asish Podder, Sri Tapash Podder and Sri Chiranjit Podder and married sister-in-law namely Smt. Papiya Majumder (Podder) and others have started to tremendous torture upon me and they treated me just like a maid servant of their house. Every time, they abuse me and my daughter with filthy and abusive languages. Whenever they required money, they created pressure upon me to bring the same from my parents and sometimes, as per their demand, my father has fulfilled their Inspector in Char relegal demand considering my future conjugal life. My husband flatly Siliguri Women r refused to incur any expenditure towards the education of my daughter.

> Sir, in the year of 2017, I have fallen ill due to their constant torture and due to heavy pain in my stomach, I have consulted with Dr. Amlanjyoti Roy and after examining me, Doctor advise me for M.R.L. and hearing the same, my husband and other in laws members refused to bear the expenditure towards my treatment and finally, with the help of my parents, I have done the M.R.I. and my parents bear all the

expenditure towards my treatment and after one year of the said treatment, again I had fallen ill and after diagnosis, it was found that I have been suffering with gallbladder stone and Doctors advised me for micro surgery and the said time, they have also refused to bear any expenditure towards my treatment and surgery and finally, my father has incurred all the expenditures towards my treatment and surgery.

Sir, my husband is a person of bad character and he abused me and my daughter with slang, dirty and abusive languages and when, I raised voice against his said attitude and behaviour, he did not bother to assault me physically and also threatened to kill me and his family members also assisted my husband for committing such type of torture and behaviour upon us. Due to the tremendous torture of my husband and in laws members, I have compelled to left my matrimonial house on 20.06.2022 and thereafter, I took shelter at my parental house for some time and thereafter, I have started to stay at my elder sister's house at Siliguri. During my stay at my elder sister's house, on 26.12.2022 my husband came to my elder sister's house at Deshbandhu Para, Siliguri and make his apology before me and my other family members and assured me that he will not commit any type of torture upon me and after receiving such type of assurance from my husband, I again went to my matrimonial house with my husband and after reaching there, sometimes, I have passed my marital life with my husband peacefully but after lapse of some period, again my husband in conspiracy with his family members have again started torture upon me and my daughter both physically and mentally. My husband has stopped to bear any expenditure towards our food, clothing's, medication and education of my daughter. He flatly denied to provide and bear any expenditure of my daughter who is presently studying in Class - XII at Jermals Academy, Siliguri and considering the said situation, I have submitted a letter before the School authority to consider the fees and other expenses of my daughter.

Since last few months, my husband and other in laws members have tried to oust me and my daughter from my matrimonial house forcefully with an intention to sold out the property and suddenly, on 28.04.2023, on the day of submitting the project paper of my daughter in the School, my husband abscond himself and inspite of thorough searching, we could not locate him and when I informed my other family members about my husband, they told me that he went outside and he will be return back very soon. After few hours, all the family members including my married sister-in-law told me that my husband out of angry, left the house by keeping a letter and they started to blaming me and my daughter about the missing of my husband and tried to assault me and my daughter but somehow, we kept confined ourselves by closing the room inside. Thereafter, I have lodged a missing dairy regarding the missing of my husband before your good office on 30.04.2023 vide Siliguri P.S. G.D. Entry No. 1726 Dated: 30.04.2023 and since then, my husband is missing. It is my strong believe that my husband in conspiracy with his family members abscond and hiding himself in a place willingly in order to flee away from his legal obligation so that, he could not make any contact with us and my other in laws members have know everything about the whereabouts of my husband.

Sir, myself and my minor daughter have been passing our days in extreme fear and anxiety as my other in laws members have conjointly

may attack upon us with ill motive and ousted us from my matrimonial house forcefully so that, they can dispose off their entire property. Sir, I have no source of income of my own and myself and my daughter have been passing our days with the help of my old aged parents and my sisters.

I, therefore, request you to kindly investigate into the matter properly and please take appropriate strong legal action against my husband and my in-laws members as mentioned above as per the provision of law and obliged thereby.
