Suresh Sah was driving the scooty and Pramir Lama act in pillion rider of that scooty, we rounded them up and questioned about their name and address when they disclosed his identity as above. On interrogation about the drugs, initially did not disclose anything about this. On further interrogation they disclosed that they procured the illegal cough syrup and injections and kept in front side of their scooty which deliver the same to another person. Then I detained them and gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Executive Magistrate. Then I informed Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC as Special Executive Magistrate to come at NH-31, near Life Line nursing home in front of Debnath shoe stores, in requested him to presence during search and seizure of the cough syrup and injections.

At 13.40hrs hrs Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC arrived at spot. Thereafter as shown by the alleged persons namely Suresh Sah and Pramir Lama I opened the front side of the scooty of having Registration No-WB74AN/5116 and found illegal cough syrup and injections inside. I asked the accused persons above named to produce document if any in support of possessing such a huge quantity of cough syrup and injections with him but they failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC as Special Executive Magistrate under proper labeling.

NATURE OF ARTICLES SEIZED

- (1) 10 (Ten) Vials LUPIGESIC INJECTION composition with Buprenorphine hydrochloride-1P equivalent to Buprenorphine 0.3Mg each vial containing 02 ML (Total-20ML) marked as Exhibit-A
- (Ten) Vials of PHENERGAN INJECTION which composition with hydrochloride-1P 25mg, each vial containing 02 ML (Total-20ML) marked as Exhibit-B
- 10 (Ten) Vials of DIAZEPAM INJECTION composition with Diazepam 1P 5 mg, each vial containing 02 ML (Total-20ML) marked as Exhibit-C
- 4) 58 (Fifty eight) bottles of PHENSEWELL cough syrup which composition Chlorpheniramine Malente 1P 4 MG Codeine phosphate 1P 10 MG each bottle containing 100 ML marked as Exhibit-D (Total-580 ML)
- 5) One Honda Aviator Scooty silver colour having Registration No-WB74AN/5116 (SL No-1,2,3 & 4 kept in front of seized Scooty which was shown by the alleged persons) (Seizure was made in between 14,10 hrs to 15,40hrs)

Under the above circumstances it is evident that the accused persons above named procured have committing offence under NDPS act. On interrogation accused persons confessed their guilt and stated that they are doing such kind of business illegally with any valid documents/License since long for their wrongful gain. It is crystal clear that the accused persons are peddling prescription drugs meant for the

sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining him about the ground of arrest issuing proper meme of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Pramir Lama @ Leeching -38yrs s/o Lt Pandu Lama of Champasari near SBI Shivajinagar PS Pradhannagar Dist Darjeeling and (2) Suresh Sah-47yrs s/o Sudarshan Sah of Champasari More Jyotinagar colony ward No-46 PS Pradhannagar Dist Darjeeling also arrange for its investigation.
