I, Salma Khatoon, wife Md Sohal, resident of "JAISWAL COMPLEX", situated at Mouza – Kalkut, JL no. 44, Pargana – Patharghata, PS – Pradhan Nagar, Dist – Darjeeling, begs to inform you that I am a tenant under one Shri. Vinod Kumar Jaiswal, son of Rajendra Prasad Jaiswal, r/o J4, 12 Civil Township, Sundargarh, Rourkela, P.O & PS – Raghunath Pali, Dist – Sundargarh, Orisha, Pin – 769004, in his complex namely "JAISWAL COMPLEX", situated at Mouza – Kalkut, recorded in LR kahtain no. 5655, corresponding to LR plot no. 159 and 307, JL no. 44, Pargana – Patharghata, PS – Pradhan Nagar, Dist – Darjeeling which was constructed by my landlord / owner i.e. Shri. Vinod Kumar Jaiswal.

Sub: FIR

That in the said Jaiswal Complex there are five shop rooms in the front side and three residential accommodations in the back side and I am residing in the back side residential accommodation with my family i.e. my husband and four children and there are four tenant in the four shop rooms in the front side of the complex and we all were residing there peacefully and paying the rent regularly to the land landlord / owner i.e. Shri. Vinod Kumar Jaiswal.

That suddenly on 15/05/2023 in the morning at about 11.20 a.m. 1) Sri. Ram Sakha Singh, son of Late Bhogi @ Bhugani Singh, 2) Sri. Ajit Kumar Singh @ Rangila, son of Sri. Ram Sakha Singh Sardar 3) Sri. Biswajit Singh @ Azad, son of Ram Sakha Singh Sardar and 4) Smt. Monika Singh, daughter in law of Sri. Ram Sakha Singh Sardar, came to the said property along with 100 men and muscleman who are local goons of the locality and bring one bulldozer cum JCB, iron rods, kukris and sharp weapons and thereafter they abused use with filthy languages and told us to quit and vacate the premises with the demand that they are the owner of the property and also threatened us if we donot vacate the premises then they will abduct my four children from and further I have face dire consequences.

That when I raised objection I manhandled by them and they molested me with intent to outrage my modesty and then they slapped me and hit me with a road in my hand when I was holding the get and resisting them from entering into my residence. That when I husband tried to protect me then he was also beaten by a road and then they tried to kill my husband by hitting him in his stomach with a shabol.

That thereafter only with intent to oust me and my family from our residential accommodation they forcibly snatched my minor children from us and started to molest them and threatened us that they will kidnap them if we do not quit and vacate the place.

That when I raised my strong objection with the help of our tenants and neighbors at that time they were compelled to leave the place but they again threatened me while leaving the place that if I do not vacate the place then they will not hesitated to kill me to take forcible possession of the land.

Sir, I am under constant fear for my life and this is my humble request to you that to take proper and strict legal action against this people.
