On 25.04.2023 at about 16:00 Hours, I, Srl Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Amarasish Mohandeo, DE (E) & 2. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Amab Ray, J.E. (E) (Grade-II) & 4. Mr. Mangru Baraik, Sr.TSH, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mrs. Bebl Devi Keshri, W/O- Harl Om Keshri, Village- South Shantinagar (Jabra Vita, Near Hanuman Mandir), P.O. – Sahudangi Hat, PS- New Jalpaigurl, District- Jalpaigurl, PIN- 735135 (Consumer ID: 401551659), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During Inspection it has been found that the aforesald accused, Mrs. Bebl Devi Keshri, W/O- Harl Om Keshri, Village-South Shantinagar (Jabra Vita, Near Hanuman Mandir), P.O. – Sahudangi Hat, PS- New Jarjariguri, District- Jalpaiguri, PIN-735135 (Consumer ID: 401551659), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 401551659 & Meter No.: L4105157 which was disconnected on 21.01.2022 due to having outstanding dues of electricity of Rs. 2381.73 (excluding LPSC). Moreover, during Inspection on 25.04.2023, the said energy meter was found 'Defective due to Desplay Off' & the service connection was found 'Physically Live' & consuming electricity at her aforementioned Domestic premises for Domestic purposes having Accessed/Inspected Load 0.440 kW. Thus the service connection was used in unauthorized manner & WBSEDCL Incurred huge amount of loss in revenue.
