In producing herewith seized one Tractor with Tolly bearing registration No. WB-71-B-6038 loaded with river bed materials i.e. Sand as per proper seizure list.

In this regards I ASI Everentius Dempta of Bagdogra PS, SPC lodged a written complaint to the effect that on 24.04.23 myself alongwith forces were performed evening mobile duty vide Bagdogra PS GDE No. 1107 dt. 24.04.23 and during mobile duty at 14-15 hrs received a source information that one Tractor was seen with carrying river bed material illegally from Tarbanda side towards Bagdogra side. Accordingly I informed the matter to you and duty officer of Bagdogra PS which noted in GDE No. 1115 dt. 24.04.24 and as per your kind instruction myself alongwith force C/283 Dani Barman and C/522 Anil Barman left for verify the veracity of the information towards Tarbanda . At 14-35 hrs we reached near Tarabari More under Bagdogra PS and found that the above noted Tractor loaded with river materials was coming from Tarbanda side . I alongwith force tried to stop the Tractor, but the driver of the said vehicle stopped the Tractor and got down from the Tractor and flee away from there. Then I checked the vehicle and found that the said Tractor was loaded with river materials i.e. sand. I tried to find the driver and waited for the owner of the vehicle, but neither the driver nor the owner of the said Tractor appears before us. It is reason to believe that the driver of the Tractor was carrying the riverbed materials by theft without any valid documents/papers illegally. During enquiry it could be ascertained that the river bed materials were loaded from Tarbanda riverside illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the vehicle having Registration No. WB-71-B-6038 loaded with river bed materials i.e. Sand as per proper seizure list in presence of witnesses. The seizure has been made in between 14-40 hrs to 14-55 hrs.

Under the above circumstances I pray that a specific case may kindly be started against the driver of above noted seized Tractor bearing registration No . WB-71-B-6038 and arrange for its investigation.
