Most humbly, I Rejesh Kumar Agarwal, S/O. Late Gulab Chand Agarwal, resident of SF Road, Maharaja, P.S. Siliguri, Dist. Darjeeling apprising you that I being the attorney of Binod Kumar Agarwal I filed a suit for declaration of title and injunction along with an application under order-39 Rule I & 2 read with section 151 of C.P.C. and after hearing the Ld. Court was pleased to pass an order of injunction in the following manner:

## Ordered

"That the prayer for an order of ad-interim injunction is allowed but in part;

That the defendants and their men and agents are hereby restrained from causing interference in the peaceful acts and possession of the plaintiff and forbidding them from encroaching any portion of the property forcibly till 17-01-2023". And the said order has been extended till 15-06-2023.
