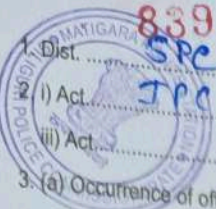

Respected Sir,

I ASI (UB)127 Paresh Ch. Roy of Kawakhali Traffic Out Post, SPC beg to lodge a written complaint that on 22/05/2023 around 17.30 hrs I have received information that 01 (one) toto vehicle registered number WB-73F/8539 is coming from Naukaghat side on AH - 02 towards Desun Hospital, PS - Matigara highly as well as unsafe loaded with various goods and causing hindrance to the General public and free flow of others vehicles. Accordingly diaries the fact in GDE above noted and also informed to O/C, Kawakhali Traffic Out post under Bagdogra Traffic guard and as directed by OC sir, I ASI Paresh Chandra Roy alongwith ASI Arindam Misra had been to the spot near Desun Hospital under Matigara PS, Dist. Darjeeling at around 17.45 Hrs and found the above noted Toto vehicle along with driver had been stationed in such a manner disrupting the free flow of trafficking, causing hindrance and danger to the General Public and other plying vehicle. On being asked he disclosed his name as Abubakkar Miah (M/30 Years) s/o- Rabbani Miah of Paschim Dhantala, Dabgram, Fulbari, PS- NJP, Dist. Jalpaiguri.

Further on being asked him to produced relevent documents in support of his claim of plying Toto on Asian Highway, but he failed to produce the same . Hence he committed the cognizable offence disturbing the free flow of vehicular of traffic and endangering the life and free movement of public in general . As such I arrested him u/s 41 Cr. P.C after preparing proper arrest Memo and briefing him about the ground of his arrest in proper way. Thereafter I also seized the toto from his possessions after preparing proper seizure list u/s 102 Cr.P.C in presence of local witness and duly attested by him and took into custody. Hence I would therefore request you to kindly start a specific case under proper section of law against above noted Toto driver and oblige.
