**Subject: Complaint Regarding Road Incident and Harassment**

Sir/Madam,

I, Smt. Leela Dutta, daughter of Joydev Dutta and a resident of 21, Rash Behari Sarani, Ward No. 17, Hakimpura, Siliguri (M.Corp), Dist: Darjeeling, am writing this letter to bring a serious incident to your attention and seek appropriate action against the individuals involved.

Yesterday i.e on the 19<sup>th</sup> May 2023 at approximately 3 PM, I was present on the road premises just outside Siliguri Court, near the "Jumbo Xerox" shop, in my four-wheeler vehicle. The road was congested with heavy traffic, and in addition to that, several vehicles were parked illegally along the roadside. While attempting to make a U-turn, a two-wheeler vehicle deliberately collided with my vehicle and falsely accused me of causing the collision.

To my dismay, a person named Ajay Biswas, accompanied by another woman, possibly a roadside vendor, arrived at the scene and magnified the situation. Mr. Biswas forcibly stopped my vehicle and prevented me from moving backward or forward, causing a significant obstruction. Moreover, he subjected

me to humiliation, verbal abuse, and name-calling. The incident unfolded in a highly chaotic and distressing manner.

I am deeply concerned about my safety and well-being in light of this incident. I fear that the person involved, Mr. Ajay Biswas, may resort to further violence or harm against me. Therefore, I kindly request your prompt intervention in this matter to ensure my protection and bring the perpetrators to justice.

Furthermore, I urge the Siliguri Police Commissionerate to take stringent action against Mr. Ajay Biswas and the accompanying woman for their unruly behavior, harassment, and obstruction of public order. It is imperative that such incidents are dealt with firmly to maintain the rule of law and restore public confidence.

In addition to the specific incident, I would like to draw your attention to the rampant issue of illegal parking along the roadside, which contributes to congestion and poses a significant hazard to traffic flow. I request that appropriate measures be taken to address this problem effectively and ensure the smooth movement of vehicles, thereby preventing such unfortunate incidents in the future.

I trust that the Siliguri Police Commissionerate will take immediate action in this matter, assuring the safety and security of citizens. I look forward to a swift resolution of this complaint and your assurance that steps will be taken to prevent the recurrence of such incidents.
