In producing herewith one arrested accused person namely Rohit Oraon (19) s/O Jamir Oraon of Ord Tea Garden, Belgachi PS Naxalbari Dist. Darjeeling with seized one Tractor with Tolly having No. WB-73-F-6564 loaded with river bed materials i.e. Sand as per proper seizure list.

In this regards I ASI Everentius Dempta of Bagdogra PS , SPC lodged a written complaint to the effect that on the night of 19/20.05.23 myself alongwith forces were performed night mobile duty vide Bagdogra PS GDE No. 960 dt. 19.05.23 and during mobile duty on 20.05.23 at 05-45 hrs received a source information that one Tractor was seen with carrying river bed material illegally from Trihanna side towards Bagdogra side. Accordingly I informed the matter to you and duty officer of Bagdogra PS and as per your kind instruction myself alongwith force C/1509 Sourav Roy Sarkar and C/511 Himadri Sekhar Adhikary left for verify the veracity of the information towards Trihanna through Panighata road . At 06-25 hrs we reached near SBI ATM Booth near Trihanna Tea Garden under Bagdogra PS and found that the above noted Tractor loaded with river materials was coming from Trihanna side. I alongwith force tried to stop the Tractor having No. WB-73-F-6564 , but the driver try to flee away from there with vehicle, on hot chased I apprehended the said Tractor with driver and found that the said vehicle was loaded with riverbed materials. On demand the driver failed to produce any documents/papers in favour of the carried the said riverbed materials and also failed to produce papers in support of the said vehicle. During enquiry it could be ascertained that the river bed materials were loaded from Trihanna River Ghat illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. Hence, As such I seized the said Tractor with tolly and loaded riverbed materials i.e. sand with proper seizure list and arrested the above noted driver of the vehicle noted above and arrest memo respectively. The seizure has been made in between 06-55 hrs to 07-25 hrs.

Under the above circumstances I pray that a specific case may kind be started against the arrested accused driver namely Rohit Oraon (19) s/O Jamir Oraon of Ord Tea Garden, Belgachi*PS Naxalbari Dist. Darjeeling of Tractory having No. WB-73-F-6564 and arrange for its investigation.
