In producing herewith seized one Vehicle having No. WB-45-4489 (Damper) loaded with river bed materials i.e. Sand as per proper seizure list.

In this regards I ASI Sushanta Sarkar of Bagdogra PS, SPC lodged a written complaint to the effect that on 20.05.23 morning at 07-55 hrs myself alongwith C/283 Dani Barman and CV-385 Amit Singha were performed morning mobile duty vide Bagdogra PS GDE No. 975 dt. 20.05.23 and during mobile duty at 10-15 hrs received a source information that one vehicle was seen with carrying river bed material illegally from Chater Hat Medical more side towards Ranidanga side. Accordingly I informed the matter to you and duty officer of Bagdogra PS and as per your kind instruction myself alongwith force left for verify the veracity of the information to Ranidanga road. At 10-45 we reached at Ranidanga road near North Point School and started checking the upcoming vehicle and found that the above noted vehicle loaded with riverbed materials was coming from Chater Hat Medical More side . I alongwith force tried to stop the vehicle, but the driver of the said vehicle stopped the vehicle and got down from the vehicle and flee away from there. Then I checked the vehicle and found that the said vehicle was loaded with river materials i.e. sand. I tried to find the driver and waited for the owner of the vehicle , but neither the driver nor the owner of the vehicle appears before us. It is reason to believe that the driver of the vehicle was carrying the riverbed materials by theft without any valid documents/papers illegally. During enquiry it could be ascertained that the riverbed materials were loaded from Tarabari river side illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the vehicle having Registration No. WB-45-4489 loaded with river bed materials i.e. Sand as per proper seizure list in presence of witnesses. The seizure has been made in between 11-35 hrs to 12-15 hrs.

Under the above circumstances I pray that a specific case may kindly be started against the driver of the seized vehicle having No. WB-45-4489 and arrange for its investigation.
