Respected Sir,

I, Smt. Laxmi Dey Roy, Wife of Sri Bablu Roy, resident of Chaitanyapur, P.O.- New Rangia, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint that on 23.05.2023, when my Husband, Sri Bablu Roy was travelling from Darjeeling More towards Salbari, by riding in his scooty bearing Registration No. WB-74-BB/6502, in a very low speed, taking the left side of the road and then suddenly, near S.I.T. Salbari, a School bus bearing Registration No. WB-76/8059 of Mahbart High School, being Bus No. '8B', dashed/collided with the scooty of my husband bearing Registration No. WB-74-BB/6502 from the behind, in a very rash and negligent manner, when the said school bus was going to overtake the aforesaid scooty of my husband and following which, a serious accident was occurred, due to rash and negligent driving by the driver of the said offending bus bearing Registration No. WB-76/8059 and for which, my husband viz. Bablu Roy has sustained severe injury in his body and also severe injury in the spleen and also inner parts of his body and he is presently admitted in I.C.U. under Supervision of ventilation of Neotia Getwell Nursing Home, Matigara and my Husband viz. Bablu Roy presently is in a serious condition as several immediate operations were done by the treating doctors for saving his life and he is continuously fighting to return back from death bed.

Sir, there was no other person to attend my husband and I was very much busy for the urgent treatment of my husband viz. Bablu Roy, so there is one day delay of lodging my complaint.

I, therefore, humbly pray with you to take an immediate drastic legal actions against the driver of the offending vehicle bearing Registration No. WB-76/8059 and also against the said offending vehicle and its owner in accordance with law and your good office and urgent cooperation is very much expected in this regard.
