I, SI Upendra Nath Roy of Bagdogra PS, Siliguri Police Commissionerate, deliguri Metropolitan Police complaint, on producing arrested accused person namely Sushanta Ganguly (45) s/o Lt. Sadhan Kumar Ganguly of Natunpara, Lataguri PS Malbazar Dist. Jalapiguri A/P C/o Raj Lakshi Hotel at Rangapani Bazar PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Thirty two (32) nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1

2. Eleven (11) sealed Bottles of Kingfisher Strong Premium beer, each bottle 650 ml each, Marked as exhibit-B in which 01 bottle taken as sample for examination exhibit-B1.

3. Three (3) nos sealed Bottles of Old Monk XXX premium RUM, each bottle 180 ml, Marked as Exhibit-C from which 01 bottles taken as sample for examination Marked as Exhibit-C1

4. Three (3) nos sealed Bottles of Mcdowells No. 1 superior whisky, each bottle 180 ml, Marked as Exhibit-D from which 01 bottles taken as sample for examination Marked as Exhibit-D1

5. Three (3) nos sealed Bottles of Mcdowells No. 1 Luxury premium whisky, each bottle 180 ml, Marked as Exhibit-E from which 01 bottles taken as sample for examination Marked as Exhibit-E1

6. four (4) nos sealed Bottles of Imperial Blue Blended grain whisky, each bottle 180 ml, Marked as Exhibit-F

7. Five (5) Ltrs Local made ID Liquor locally called as "Cholai" which kept in one Plastic Jar Marked as Exhibit – G in which 01 Ltr taken as sample in a Plastic bottle for examination exhibit-G1.

I am submitting a written complaint against the above noted accused person to the effect that today 22.05.23 at 22-10 hrs received secrete source of information that one person was selling Id Liquor illegally from his Shop styled as Raj Lakshi Hotel at Rangapani Bazar to its customers without any valid license. Accordingly I informed to the duty officer of Bagdogra PS and also O.C. Bagdogra PS and as per his instruction myself along with ASI Sadananda Debnath, ASI(AB) Sunil Chandra Roy, CV- 389 Janak Singh, VP- 01 Ansalam Kujur left for Rangapani Bazar to verify the veracity of information which noted in GD vide Bagdogra PS GDE No. 1114 dt. 22.05.23. On arrival at the spot at 22-25 hrs it was found that one person mention above was selling liquor illegally from the shop styled as Raj Lakshi Hotel at Rangapani Bazar to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above and also stated that he and owner of the said Hotel namely Rintu Sarkar S/o Bamkim Ch. Sarkar jointly do this business and the owner of the said Hotel manage to flew away from the shop during raid by Police to avoid police arrest. Thereafter in presence of witnesses (1) Prakash Barman s/o Jay Narayan Barman of Dhansara jote PS Bagdogra Dist. Darjeeling and (2) ASI(AB) Sunil Chandra Roy of Rangapani OP ( SAP 12th Battalion) PS Bagdogra, SPC, I recovered huge quantity of Liquor mentioned above from the possession of the apprehended person from the said Shop named Raj Lakshi Hotel and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor from the said shop and confessed his guilt. During further interrogation it came to know that the owner of Raj Lakshi Hotel namely Rintu Sarkar and the above noted accused person jointly carrying the said business illegally from Raj Lakshi Hotel to earn huge money for their livelihood. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 22-45 hrs and 23-

Therefore, I request you to start a specific case under proper section of law against two accused person namely (1) Sushanta Ganguly (45) s/o Lt. Sadhan Kumar Ganguly of Natunpara, Lataguri PS Malbazar Dist. Jalapiguri A/P C/o Raj Lakshi Hotel at Rangapani Bazar PS Bagdogra Dist. Darjeeling and (2) Rintu Sarkar S/o its investigation.
