But suddenly they started to misbehave  
with us. They told us to give a  
sum of 25 lakh of money or a land  
entertainment money. They also mentioned  
that both of them are send by

by Ratan mahato & Jay Ram mishra.  
we tried to stop them, but they were  
abusive words and assaulted us. They also  
threaten us saying that they are powerful  
people and all the police are in their  
pocket. And no one can protect us from  
them. They also put me & my family in  
fear of murder & rape of my daughter.

When I started screaming for help one  
of them twisted my hand in such a  
way that I cried in pain. Being so  
helpless and weak I was unable to  
save myself from them. After seeing  
the my daughter started to throw  
stone at them to save me. They  
immediately ran away leaving their  
motor bike no. WB 74 4067 inside  
our house premises (after that police  
came and took the bike with them giving  
us a copy of seizure list) One of  
them claim to be a police officer  
and bring police force to arrest us.

They also came yesterday on 26/05/23  
around 9 o'clock to threaten us  
demanding money as extortation and  
if were unable to bring money they  
bring people and forcefully vacant  
our land.

These people Raban mahant, prasangit  
mandal, hujit mandal & Jay Ram  
muthia are local goons & dangerous  
renowned land maffias. There was not  
the first time they assaulted & trespass  
our house.

I kindly request you to take strict  
action against them because these  
people are dangerous in nature &  
my & my daughter life are in danger.
