I, the above named complainant, would wish to lodge this FIR against the above named accused person with respect to:

That I got married to Sri Manik Kumar Bhadra on 24th June, 2014 by observing Hindu rites. Both the families gave that marriage and we have registered it on 23rd October, 2016. But within 3 months from the date of marriage, my husband had started to enter into illicit relationship with other women and whenever I used to question him about it, he used to give my flimsy answers about it and later on he used to admit the same. Even after the birth of our daughter, the adulterous activities of my husband did not stop, rather it accelerated and even at present, he is in a relationship with another lady. It is also important to state that my husband is a habitual alcoholic and very much abusive in nature.

On 22/05/2023, when my husband came late night at a drunken state, I asked him his whereabouts, and under heavy influence of alcohol he very badly abused and beaten me and I could not get up from bed for few days. My mother-in-law, brother-in-law and sister-in-law (as above named) had always tortured me mentally and physically for a number of times and on 22/05/2023, all of them had also slapped me and tried to get me out of my matrimonial home. I am now living at my husband's home, but in a terrible bad and frightened mental state that I would be physically hurt and my life is at risk. My parents are very poor and they do not have sufficient means to maintain me or to keep me at their one room rented home. And here I am regularly being tortured by the accused persons both mentally and physically.

In the above situation, I request you to kindly take necessary legal actions against the accused persons and oblige me.
