Sir,

In producing herewith one seized vehicles tractor along with trolley bearing registration no WB 91/TC - 01 partially loaded with river bed materials (stone). I ASI Anupam Roy of NBMC OP Under Matigara. PS beg to lodge a written complaint against the driver & owner of the above mentioned vehicle, to the effect that today i.e 31.05.2023 in course of mobile van duty vide NBMC OP GDE No 792 dated 31.05.2023 I along with C/ 340 Pranab Adhikary & C/1085 Mithun Debnath reached at Kalam Jote Ghat of Balason river under Matigara PS and found that some persons were loading river bed materials in a tractor along with trolley the tractor have in the middle of the rivers, seeing the police van driver of the tractor are fled away from the spot. There is sufficient reason to believe that the above noted tractor driver & owner have stolen river bed materials from the river of Balason at Kalam Jote Ghat for selling clandestinely. Accordingly, I seized above noted tractor along with trolley bearing registration no WB 91/TC - 01 partially loaded with river bed materials (stone) under proper seizure list. The search, seizure was made in between 19.05 hrs to 19.40 hrs on 31.05.2023.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted vehicle may kindly be started and arrange for its investigation.
