Sir,

In producing herewith one arrested lady namely Lappa Sherpa (F/60yrs) W/O- Dawa Sherpa of Pipe Line near BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1] 06 (Six) bottles of Kingfisher strong beer (each bottle containing 650 ml)
- 2] 08 (Eight) bottles of Tuborg strong beer (each bottle containing 650 ml)
- 3] 08 (Eight) bottles of Himalayan Gold 60UP country spirit (each bottle containing 600 ml)
- 4] 30 (Thirty) bottles of Himalayan Fatafati 70 UP country spirit (each bottle containing 300 ml)

I, PSI Koushik Raha S/O- Jitendra Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one lady namely Lappa Sherpa (F/60yrs) W/O- Dawa Sherpa of Pipe Line near BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri to the effect that today on 29.05.2023 at 14.05 hrs while performing evening patrolling duty, received a source information that one lady namely Lappa Sherpa (F/60yrs) is selling liquor in his house at Pipe Line near BSF road, Salugara under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C Bhaktinagar PS and as per his kind direction and vide Bhaktinagar PS GDE NO-1378 Dt-29.05.23 myself along with force- C/915 Chandra Prakash Adhikary, C/1431 Dilip Barman, C/374 Debraj Biswas, LCV/1060 Goma Bhandari had been to Pipe Line near BSF road, Salugara under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the house and with the help of LCV/1060 Goma Bhandari able to detain the above noted lady. Subsequently on being asked the apprehended person disclosed her name and identity as noted above and stated that she is the owner of the house. Further being searched the above noted seized articles were found in the said house. On demand she failed to produce any valid license/papers for selling and storing of such articles. On further interrogation she stated that she is involved in selling and possessing of liquor without any valid license for last 06 (six) months for her illegal gain. Then I seized the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Lappa Sherpa (F/60yrs) W/O- Dawa Sherpa of Pipe Line near BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri U/S 41 Cr. P.C. after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 14:55 hrs to 16:05 hrs at the spot and arrested her after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Lappa Sherpa (F/60yrs) W/O- Dawa Sherpa of Pipe Line near BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
