l, PSI Koushik Raha S/O- Jitendra Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one lady namely Lappa Sherpa (F/60yrs) W/O- Dawa Sherpa of Pipe Line near BSF road, P.O- Salugara, P.S-Bhaktinagar, Dist-Jalpaiguri to the effect that today on 29.05.2023 at 14.05 hrs while performing evening patrolling duty, received a source information that one lady namely Lappa Sherpa (F/60yrs) is selling liquor in his house at Pipe Line near BSF road, Salugara under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C Bhaktinagar PS and as per his kind direction and vide Bhaktinagar PS GDE NO-1378 Dt-29.05.23 myself along with force- C/915 Chandra Prakash Adhikary, C/1431 Dilip Barman, C/374 Debraj Biswas, LCV/1060 Goma Bhandari had been to Pipe Line near BSF road, Salugara under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the house and with the help of LCV/1060 Goma Bhandari able to detain the above noted lady. P.C. after observing all sorts of formalities at the spot.
