**SUB: Intimation of a non-fatal electrical accident of Sri Sumit Barman occurred on 30.05.2023 at about 04:30 pm inside Agrasen Bhawan, Agrasen Road, Khalpara, PS & PO: Siliguri Pin: 734005 under the jurisdiction of Siliguri Town Division.**

Sir,

I, Sri Soumyadeep Ganguly, S/O Sri Sibnath Ganguly posted as Divisional Engineer at Siliguri Town Division would like to inform you that an electrical accident occurred on 30.05.2023 around 04:35 pm inside Agrasen Bhawan, Agrasen Road, Khalpara, PS & PO: Siliguri Pin: 734005. The victim Sri Sumit Barman, of age reportedly about 45 years, a contractual labourer under contractor Sri Fani Bhusan Barman (Mob: 8327367176/ 9002019102) was working at Agrasen Bhawan for installation of marble slabs. He was using a drill machine to drill the surface of the building. During this activity he ran his drill machine through the outgoing consumer end PVC electric cable which was buried under the surface and which is passing from WBSEDCL Bulk meter room to the consumers LT panel. Due to this, the drill machine pierced the PVC insulation of the cable and came in contact with live conductors causing electrocution of the victim. The victim reportedly received burn injuries in his chest and right hand. He was immediately taken to Arogya Niketan Nursing Home, wherefrom he was referred to Shanti Nursing Home, Siliguri. The victim is currently admitted at Shanti Nursing Home and is undergoing treatment there.

The accident has taken place due to the negligence of the LT Bulk consumer (Agrasen Bhawan authorities) as they failed to take proper shutdown from WBSEDCL prior to engaging labourers at the aforementioned work.
