That after the said marriage I was torture by the in-laws and my Husband and I was forced to left my matrimonial house , I lodged one FIR against them before the I/C Pradhan Nagar, Darjeeling but after few days he came to my father's house and apologize on his acts and activities , being a lady I gave him another chance and I went to my matrimonial house with a great hope to lead a beautiful married life with him but that this was a awful story and again he and his family members torture and tried to kill me there , I ,any how escaped from there , then and then Pradhan Nagar Police started another criminal case against him in the year 2022 , 4th day of January .

Sir, it is to inform you that since that date I am residing at my father's house with my 12 years old child and my father is taking care of us.

Sir, since few days my above named husband called me over telephone threatening me of my life and abused me with filthy languages.
