Sir,

In producing herewith one (01) arrested accused person namely Sujan Sharma (24) S/O Lt. Sukomal Sharma, 1 No. Gate, PS Dinhata, Dist. Cooch Behar along with the following articles under seizure as per seizure list;

- 1. One Auto Pistol inscribed as 'Auto pistol Made in USA' having its trigger, hammer and firing pin measuring approx. 8.3 inch (approx.) including its butt, body loaded with four live ammunitions inscribed as "KF" and "7.65" on its percussion cap. [The articles have been found kept concealed on the right side of waist of accused Sujan Sharma marked as "Exhibit-A"]
- 2. Two live ammunitions loaded in one extra magazine inscribed as "KF" and "7.65" on its percussion cap found inside the left side pocket of black color jeans pant of accused Sujan Sharma & marked as "Exhibit-B"]

I, ASI Biplab Kumar Das(38 years) S/O Nikhil Ch. Das of Pradhan Nagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against the above noted one (01) arrested accused person namely Sujan Sharma (24) S/O Lt. Sukomal Sharma, 1 No. Gate, PS Dinhata, Dist. Cooch Behar to the effect that today on 01.06.2023 at about 20.15 hrs I received a specific source input that one person was standing near Circuit House more under Pradhan Nagar PS, for committing heinous crime. He had carried and possesses small arms & ammunition with him. The matter was diarized vide Pradhan Nagar PS GDE No.1988 Dt. 01.06.2023. Accordingly, I informed the matter to your kind notice, and subsequently, as per your kind direction myself along with ASI Manoj Kumar Roy, CV/242 Rakesh Mangar, CV/646 Baban Das and CV/992 Jagadis Biswas all of Pradhan Nagar PS and along with investigation kit left for Circuit House more by govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No.1988 Dt. 01.06.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter I along with officer and force reached at Circuit house more at 20.30 hrs and I requested two persons as independent witness by notice namely (Dulal Roy (28) s/o Nepal Roy of Darjeeling more, Rajiv Nagar, PS Pradhan Nagar, Dist. Darjeeling and Pradeep Mahato (30) s/o Lt. Lakhan Mahato of Darjeeling more, Rajiv Nagar, PS Pradhan Nagar, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and offered the independent witnesses to search our Police Party as per provisions, they searched the police party and found our service revolver and wearing apparels only and thereafter being pointed by my source apprehended the above noted accused person named Sujan Sharma and subsequently I searched him immediately and found the above noted articles from his conscious and exclusive possession. On demand he failed to produce any documents in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused person namely Sujan Sharma, exclusively & consciously possessed this fire arm along with live ammunition illegally with some ill motives.

Thus, his involvement in carrying and possessing illegal fire arms and ammunition is established, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by the accused person, in presence of independent witnesses namely Dulal Roy (28) s/o Nepal Roy of Darjeeling more, Rajiv Nagar, PS Pradhan Nagar, Dist. Darjeeling and Pradeep Mahato (30) s/o Lt. Lakhan Mahato of Darjeeling more, Rajiv Nagar, PS Pradhan Nagar, Dist. Darjeeling and also put my signature on the seizure list and label. The seizure time was made between 20.50 to 21.55 hrs. Subsequently, I also arrested him preparing memo of arrest informing him the ground of his arrest.

From the above noted facts and seizure of incriminating articles there is a strong reason to believe that the accused person namely Sujan Sharma had carried the said fire arms and ammunitions with an objective to commit heinous crime in the locality and on being interrogated regarding the illegal arms and ammunition recovered from his exclusive and conscious possession, he revealed that he has procured the arms and ammunition from somewhere in Cooch Behar area.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Sujan Sharma (24) S/O Lt. Sukomal Sharma, 1 No. Gate, PS Dinhata, Dist. Cooch Behar and arrange for its investigation.
