### SUB COMPLAINT

1. **SMT. SAMPA ROY**, Wife of **Sri Gopal Das**, Indian by Nationality, Hindu by religion, House-Wife by Occupation, resident of Panchanan Colony, Ward No. 02 of Siliguri Municipal Corporation, P.O. & P.S. Pradhan Nagar, Pin- 734001, Dist. Darjeeling, in the State of West Bengal, would like to state as follows

That am the legally married of "Gopal Das", S/O Late Narayan Chandra Das, and marriage was solemnized on 14-12-2016 at Devidanga Temple, Champasari, in presence of the well wishers of both of us.

That out of the said wedlock one female child namely "Diya Das" was born on 21-03-2019.

That since marriage my husband and my in-laws have been harassing me and torturing me mentally and physically and from time to time they have been demanding money from me and my parents.


That my parents are poor persons and my father works at a private firm, but from time to my sister-in-law namely "Shibani Saha", "Sampa Das" & "Parul Barman" together with my mother-in-law "Milan Das", used to demand money from me and I somehow used to manage money from my father and used to give them money as per their demands.

That my husband is a "thekadar" and earns good money, he regularly comes to our house late in night in heavily drunken condition and regularly assaults me and beat me and insults me in filthy language almost daily and demands money from me regularly.

That on 01-05-2023, my husband and in-laws demanded money from me and since I refused to bring money from my parents, they severally beat me on my left forearm with iron rod and I sustained serious injury on the said forearm.
