I, ASI Inzamamul Haque of Khalpara TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 04/06/2023 at 18:15 hrs during evening raid duty I received secret source information that, one person is selling huge quantity of country spirit at Natunpara, Ram Ghat, opp. Pradip Yubak Sangha, Ward No 05, PS- Siliguri Dist-Darjeeling under KhalparaTOP. Accordingly I informed the information to OC Khalpara TOP and as per his direction I along with ASI Kalachand Singha, C/678 Dipak Mandal, C/ 284 Shankar Singha, CV-980 Ranjan Kr. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Natunpara, Ram Ghat and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SI. No- 01. Under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 20:05 hrs to 20:25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining

charge against him. Total value of seized articles is Rs. 1550/-
