Sir,

In producing herewith four (04) arrested accused persons namely (1) Ajay Barman (M/19) S/O- Lt. Goutam Barman of koyla depot W/No - 07, PS. Siliguri, Dist. Darjeeling, (2) Golam Mustafa @ Md.Kalu (M/32), S/O- Lt. Md. Lal of Darbhanga Tola ,W/No - 06, PS. Siliguri, Dist. Darjeeling (3) Biitu Das (M/20), S/O- Yadav Das of Tikiya Para, Matangini Colony-II, W/No - 28, PS. Siliguri, Dist. Darjeeling, and (4) Md. Riyaj (M/29), S/O- Md. Rafike of Raja Holly, W/No - 35, PS.NJP, Dist. Jalpaiguri of arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One metal made knife measuring about 12 inch (approx) including wooden butt from the possession of Ajay Barman which was kept on his right hand,
- (2) One iron claw bar measuring 18 inch (approx), from the possession of Golam Mustafa @ Md.Kalu which was kept on his hand.
- (3) One iron hammer measuring 24 inch (approx) including wooden butt, from the possession of Biitu Das which was kept on his hand.
- (4) One metal made Rambo Knife measuring 11 inch (approx) including wooden handle from the possession of Md. Riyaj which was kept concealed on his back side,

I, ASI- Subir Sen S/O Lt Sachindra Nath Sen of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Ajay Barman, Golam Mustafa @ Md.Kalu, Biitu Das, Md. Riyaj and others to the effect that today on 08.06.2023 at 00.05 hrs received a sources information that 12/13 youths have assembled at Fuleswari, Railway Line near Fish Market with a view to commit dacoity in a house at Uttar Bharat Nagar area. The fact was diarized in GD vide Siliguri PS GDE No- 438, dated 08.06.2023. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Debasish Das, CV/622 Ramanath Barman and CV/283 Prasenjit Dey, left for the place to work out the information. On way I contact ASI Rabin Lama who was performing k-21 Van to accompany us to work-out the information. We reached at Fuleswari, Fish Market at 00.55 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Railway Line and seeing police personnel they tried to flee away from the spot but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Uttar Bharat Nagar area with the leadership of Md. Riyaj.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.25 hrs to 02.05 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

Accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Uttar Bharat Nagar area. It is also revealed from them that (1) Raja, (2) Bihar, (3) Prakash, (4) Md. Ali and some others have been assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Ajay Barman (M/19) S/O- Lt. Goutam Barman of Koyla depot W/No - 07, PS. Siliguri, Dist. Darjeeling, (2) Golam Mustafa @ Md. Kalu (M/32), S/O- Lt. Md. Lal of Darbhanga Tola, W/No - 06, PS. Siliguri, Dist. Darjeeling (3) Bittu Das (M/20), S/O- Yadav Das of Tikiya Para, Matangini Colony-II, W/No - 28, PS. Siliguri, Dist. Darjeeling, and (4) Md. Riyaj (M/29), S/O- Md. Rafique of Raja Holly, W/No - 35, PS. NJP, Dist. Jalpaiguri (5) Raja, (6) Bihar, (7) Prakash, (8) Md. Ali and others and arrange for its investigation.
