As per your kind direction and instruction myself along with ASI-Dhruba Mishra , C/453 Uttam Roy & VP/13 Jamirul Islma all of NJP PS, SPC left for Gorarbari, near Mamtapara, PS- NJP, Dist.-Jalpaiguri to work out the information in hand.
