In producing herewith one arrested accused person namely Nikhil Das (50yrs), s/o – Nani Gopal Das, of – Purba Rangia, Chaitannyapur, PS – Matigara, Dist – Darjeeling along with one seized vehicle (Truck) bearing registration no WB 73 D / 9492 loaded with river bed materials (Stone).

I ASI Prem Bhakta Mallick of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver of the above mentioned vehicle named Nikhil Das and the owner of the vehicle bearing registration no WB 73 D / 9492 , to the effect that today on 12.06.2023 at 17.15 hrs in course of evening van duty vide MCC No 762 dated 12.06.2023 | along with C/ 210 Prasanta Mardi & C/367 Avijit Roy reached at Balason River at Kalam Jote Ghat under Matigara PS, Dist - Darjeeling and found that some persons were loading river bed materials in a Truck bearing registration no WB 72 0 / 9492 from the river of Balason under Darjeeling District. Seeing the police van the driver of Truck and others are trying to fled away from the spot, but we managed to intercept the above noted vehicle and apprehended above noted person. On interrogation he disclose his name and identity as Nikhil Das (50yrs), s/o - Nani Gopal Das, of - Purba Rangia, Chaitannyapur, PS - Matigara, Dist - Darjeeling and confessed that he is the driver of above noted Truck, he also confessed that he along with others were stealing the river bed materials (Stone) from the river of Balason at Kalam Jote Ghat under Matigara PS, Dist - Darjeeling for selling clandestinely. On demand the above noted accused person failed to produce any document for possessing the river bed materials and he also stated that as per direction of owner of the Truck bearing registration no WB 73 D / 9492 he stolen the river bed materials (Stone) from Kalam Jote Ghat under Matigara PS, Dist - Darjeeling. There is sufficient reason to believe that the above noted vehicle driver have stolen river bed materials (Stone) from the river of Balason at Kalam Jote Ghat under Matigara PS, Dist - Darjeeling for selling clandestinely. Accordingly, I seized the vehicles Truck bearing registration no WB 73 D / 9492 loaded with river bed materials (Stone) under proper seizure list and arrest the above noted person U/S 41 Cr.P.C informing him the ground of arrest after issuing Memo of arrest. The search, seizure and arrest were made in between 17.55 hrs and 18.25 hrs on 12.06.2023.
