Bose 10/4 13 Road, Collage Para, beside Bandhab Sanga Club, P.O. & P.S. Siliguri, 13:35hn vide District Darjeeling beg to inform you that my marriage was solemnized Sla women GIDEN6-255 on 27/01/2023 as per hindu rights and rituals at Deokota Sangha, Pradhan Nagar with Samiran Ghosh, S/0- Sri Arun Kumar Ghosh, =11- 10/6, Wis and regulared resident of 3rd Floor, Gitanjali Apartment beside Habu Aata Mill, Sa writer b Rabindra Nagar, P.O. Rabindra Sarani, P.S. Siliguri, District Darjeeling. Care no - 76/13 di-10 16 17 1/2 Prior to Marriage my Ashirbad ceremony was held at Amravati Hotel, S.F. Road, Siliguri on 05/08/2022. After marriage I was taken to the HACABOUAT Section 400 kg-above noted address of my matrimonial house where I started my new and endroed marital life with my husband and my parents-in-law namely Sri Arun To Uto | Syadami Kumar Ghosh, (father-in-law) and Smt. Supriya Ghosh (Mother-in-law) as well as with my husband Sri Samiran Ghosh. I have one married Saha for Us sister-in-law namely Anuja Ghosh, wife of Sri Debanjan Ghosh and her untique 16 husband who resided as Tollygunj, Kolkata. That very inception of my marriage my husband went to Delhi for his business work as he settled there leaving me in the custody of my parents-in-law.

SILIGURI POLICE COMMISSIONER leaving my husband and my parents-in-law both started mental torture upon me and started to commissions. torture upon me and started to continuous demand for huge amount of money with the plea that the business of my husband is not in a good position presently. During marriage my mother tried to fulfill their

demand as per her level best. But that was not as per expectation of my husband and parents-in-law. They continuous pressure one to ask money from my mother. My husband and in-laws prior to my marriage assure that my husband is a well-established business person and he earns about 10 lakhs per month having his office at Lakshmi Nagar area, Delhi and also reside there in a good flat. They also assured me that this is not possible for my husband to come in Siliguri frequently. That is why I have to go to Delhi with him permanently. Prior to marriage I worked as a permanent teacher at Jermels Academy, Hakim Para, Siliguri since last 8 years. They compelled me to resign from my job. But presently and in-laws intimated me If I want to go to Delhi then my mother should furnish the flat with all furniture's, including Air Condition in three bed rooms, a large fridge for kitchen, washing machine, sofa set, modular kitchen as well as required all furniture's or decorating the flat. On 07/06/2023 my husband sent a ticket for me from Bagdogra to Delhi flight for dated 09/06/2023. I came to my parental house few months ago due to continuous misbehavior of inlaws and husbands. During this period from marriage to present date my husband never called me over phone properly. Even he never sent any money to me for my day to day expenditure. On 07/06/2023 at about 11:00 pm at night suddenly my husband called me and used filthy language towards me and also told me why am I not stayed at my matrimonial house with my parents-in-law? I tried to convince that due to the ill-behavior of my parents-in-laws I cannot stay there. They bound to stay me there in a suffocative environment.

That they did tremendous mental torture over phone on 08/06/2023 at about 7:00 - 7:30 pm. I went to my matrimonial house along with my younger sister where my parents -in-law started to torture assaulting me and my mother-in-law also supported him. When I entered into my bedroom taking necessary documents and wearing apparels suddenly my father-in-law assaulted me with bad touch upon my body and then

on then I resist him but my father-in-law became more furious and started to beat me with blow and fist and slaps locking my bedroom from inside. Anyhow I saved myself from him. Due to their such behaviour me and my sister both became spellbound for few moments. And my sister somehow managed to inform my mother over phone. After getting information and my maternal uncle and a well-wisher of my family Prasanta Dutta rescued us. Due to mental trauma, I am not able to lodge this complaint on 09/06/2023.

Therefore, I requesting you to kindly investigate the matter and to take proper legal action against all of my in laws and husband as per law.
