That I along with 24 others are the joint <sup>owner</sup> ~~owner~~ of land  
measuring 5.09 Acre appertaining to R.S. Khation No 60/1 & 60/4,  
L.R. Khation No. 262, R.S. Plot No 888 corresponding to L.R Plot  
NO: 543, 544, 545 and 546 within marza - DUMRISUR, R.S. JL No 81,  
L.R. JL No: 94, P.S. Naxalbari, Dist: Daryjeeling.

That from last 1-2 years, some unknown anti social elements  
tried to occupy the same portion of our land illegally and -  
contemptfully and they also disturbing our peaceful possession.  
when we made protest then they threatened us by using filthy  
languages.

It is to be mentioned here that two civil suit has  
been pending with respect to the aforesaid land before the  
hon'ble High Court at Calcutta.

That during the pendency of this suit on 18.06.2023 again  
some unknown anti social element entering in our land with an  
intention to occupy the same, but who came and has been  
said small "kaccha" barrack and night, I don't know.

So, therefore, prayed that please investigate the matter  
and punish the said unknown anti social elements and their  
illegal acts and activities.
