Nights with hotel accomdation, sightseeing , food and transport for the entire tour and the tour was booked by me on 5° Feb 2023 after coordinating with Mr Rahul Roy who had contacted me via Tripcrafter.com a tour lead generator company based out of Deihi who had referred my inquiry to Mr Rahul Roy.

The entire tour cost was finalized with Mr Rahul Roy of Tour Maker Holidays at a price of Rs 6,50000/- (six lakh fifty thousand) all inclusive of the hotel stay (4° Star category hotels), sightseeing, food and transport via confirmation of the quotation on tour maker holidays letter head which was received by me in the month of Feb 2023. After finalization I was asked by Mr Rahul Roy to deposit 50% of the package cost Rs 325000/- (three lakh twenty five thousand) Plus Rs 20000 (twenty thousand) for additional person so total of Rs 345000/- was transferred to Bandhan bank account account No = 50200003434135.

After payment I received the booking confirmation voucher issued by Tour maker holidays from Mt Rahul Toy confirming my booking of the hotels, after few days I contacted the listed hotels in the voucher i.e. All 5 hotels for the entire tour and to my surprise it was conveyed to me by the hotel staff that hotel booking request is received from Mr Rahul Roy for myself but the booking of rooms is not done as payment has not been done by Mr Rahul Roy and they will not allocate the rooms until payment is received. I contacted Mr Rahul roy and confronted him with the details of rooms being not booked he assured me that hotel is booked and he will share me the hotel voucher with confirmed room booking in few days, as few days passed I again contacted Mr Rahul Roy in the 1th week of March 2023 and he stopped taking my calls or responding to my messages. I repeatedly contacted Mr Rahul Roy for 3 weeks but there was no response. And I came to know that I have been cheated and fraudently money was taken from me by Mr Rahul roy and I demanded refund of entire advance amount paid by me Rs 345000/- to which Mr Rahul roy didn't respond.

Post that I had to again book the hotels for the entire trip of 9 days for me and my family of 22 people at a higher rate and again booked through a genuine tour operator in Sikkim for Five takhs only for hotels.

On 25th merch 2023 I again called Mr Rahul roy from other mobile no and he picked my call and said that hotel rooms is not booked and he has booked my transport only for 252000/- (two lakhs fifty
