I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that on 18.06.2023 at 1635 hrs I received a secret source information that one person namely Bablu Gain ws/o Lt. Panchamen Gain of Pachim Dhantala, Battalion More, PS- New Jalpaiguri, Dist.-Jalpaiguri is selling ID liquor illegally at Battalion More, under New Jalpaiguri, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 927 date: 18.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with ASI-Dhruba Mishra, C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for Battalion More, PS- New Jalpaiguri, Dist.-Jalpaiguri to work out the information in hand. At 1715 hrs we arrived at the shop of Bablu Gain ws/o Lt. Panchamen Gain of Pachim Dhantala, Battalion More, PS- New Jalpaiguri, Dist.-Jalpaiguri and being identified by the source I held raid at the shop of Bablu Gain at Battalion More where the above noted accused person selling ID Liquior. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest.
