This is to inform you that Shri Goutam Deb, Hon'ble Mayor of Siliguri Municipal Corporation is running a page in the name of "Gautam Deb" of which the link is given above. The page is being used to update his regular social and political activities on facebook. Various Civic issues and developmental updates including his political programmes are being updated on his facebook page. This is a verified page with blue tick. The page has 3(three) admins and the page is being promoted by an ad account 'Gautam Deb' which was also verified by facebook. In this regard this is to mention here that an ad is presently running to promote this page. The page was created in the year 2014. Since then the page was managed by this account 'Gautam Deb' and being promoted since last 6 years.

Generally the page used to be opened through inserting email id (i.e. gautamdebmictourism@gmail.com) and password and after opening the account 'Gaulam Deb' the page used to be opened. The last post was occurred on 18.06 2023 (Sunday) in the morning. But suddenly from yesterday morning i.e. 19.06,2023 the account has lost the page as well as another 2(two) admins also lost the page and the page was not showing from any admin's

Under the circumstances, we tried to connect with Facebook team and had a conversation with Meta Pro account. Team today (20.06.2023) morning and they send a mail asking several ID proofs and other documents. We provided some documents through e-mail also. But this is very much shocking that at around 7 pm today we noticed that the posts of 2023 automatically vanished from the above mentioned page and profile photo of the page updated

We don't know what is happening to this page! Shri Gautam Deb is a significant politician of All India Trinamool Congress and held various important posts in West Bengal State Level Committee. He was 4 times Darjeeling District Trinamool Congress President as well as 2 times North Bengal Core-Committee Chairman. He served as Cabinet Minister of West Bengal for 2 consecutive periods. Presently he is acting as the Mayor of Siliguri Municipal Corporation. Under this situation we are assuming that his facebook page may be hacked by someone to malign the image of Hon'ble Mayor.

Hence, you are requested to take immediate necessary action to help us to regain the access of his page and prevent any kind of unauthorised activities on his page as early as possible.
