I am . Gurinjan Singh son of Late Chananjit Singh,  
Seroke road, ward no 11, opp. nine ten hotel.

Yesterday on 20/6/2023 time 6:52 am Sarabjeet Singh  
and his wife Kamaljit Kaur came from ward no 40,  
Saratchandrapally. Kamaljit Kaur attack my mother  
with iron rod, she badly injured my mother and  
tried to push iron rod on my mother stomach  
to murder my mom Lata Kaur. At that moment  
Sarabjeet Singh ran beaten me by iron rod and tried  
to murder me with knife. He want to insert knife  
in my chest. But I save my chest with my hand  
in self protection, it made badly injured in my hand.  
He tried to cut my respiratory organ neck. By  
saving my neck then it get cut in my back of  
ear, instead of neck. Then I was running to road  
in way of police. But at that moment I saw  
Police van on road, I and my mother shouted "police  
police". We told matter to police, we show our injury.

Police arrested Sarabjeet Singh from infront of my  
building. But after going Police Satbinder Kaur,  
Dipika chetty, Gurbinder Singh came with dagger within  
5 mins. Satbinder Kaur order them "Ajj Kissa  
Khatam Karo". Kamaljit Kaur run with iron rod.  
Gurbinder Singh and his wife Dipika chetty both  
ran in main road with dagger to murder my  
mother in front of my building. My mother  
shouted "bachao bachao", at that moment.

One running toto saw and pull my mother in toto and ran away to hospital and save my mother life. This five family members always try to kill us. In this area they had created the fear atmosphere.

Everyone fear this five family members. They are aggressive, ferocious and cruel character.

They always catch my sister in road and try to kill her. I, my mother and my sister life is in full danger.

Our life and property is in danger.

This five family members are continuously attacking us for murder.

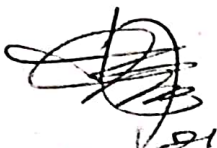
Please save us and our property from this five family members.
