

One sharp cutting knife and one Iron Road from the possession of accused Shankar Mahanto (45) s/o LL Sitaram Mahanto of Tinbatti Colony, ward No.-32, PS- New Jalpaiguri, Dist.- Jalpaiguri

One Iron made Hasua and one small hammer from the possession of accused Md. Salman (26) s/o Md. Irfan Ali of Tinbatti Colony, ward No.-32, PS- New Jalpaiguri, Dist.- Japaiguri.

One Iron Hammer & One Blunt Iron Rod from the possession of Rabi Mitra (30) s/o Lt. Khitish Mitra of Pandu Maligoan, PS- Chalukbari, Dist.- Kamrup, Assam-780012 a/p Ambikanagar, PS-New Jalpaiguri, Dist.- Jalpaiguri.

I, 'SI-Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 23.06.2023 at 0045 hrs I received a secret source information that a gang of miscreants come to Putimari, near Dangapara Sporting Club with deadly weapons and assembled there and making preparation for committing dacoity at Putimari area. Accordingly, I informed the fact to you and diarized the fact in General diary vide NJP PS GDE No 1137 dated 23.06.2023. As per kind order myself along with ASI Khagen Barman, C/1044 Hari Kherwar, VP/13 Jamirul Islam, C/453 Uttam Dey, CV/306 Bisawajit Roy CV/824 Niru Kumar Yadav all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Putimari, near Dangapara Sporting Club , PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer SI-Kamlesh Joddar of New Jalpaiguri PS, Siliguri Police Commissionerate along with force and directed him to come to Putimari to accompany with us. At about 0115 hrs on 23.06.2023 we arrived at Putimari, near Dangapara Sporting Club, PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while SI-Kamlesh Joddar along with force came to Putimar, near Dangapara Sporting Club and accompany with us. After arrival of the spot and as identified by the source we found that 10/11 persons assembled in a dark place at Putimari, near Dangapara Sporting Club, under New Jalpaiguri PS, Dist.- Jalpaiguri and they were wishpering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Putimari area. They also stated that others 06/07 associates were able to fled away from the spot by taking advantages of darkness. On search of the apprehended accused persons found (i) One Blunt Iron Road & One Torch Ligh and One hojali from the possession of accused Karan Basfore (22) (ii) One sharp cutting knife and one Iron Road from the possession of accused Shankar Mahanto (45) (iii) One Iron made Hasua & one small hammer from the possession of accused Md. Salman (26) (iv) One Iron Hammer & One Blunt Iron Rod from the possession of Rabi Mitra (30). During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity in a house at Putimari area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 0155 hrs to

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Karan Basfore (22) s/o Suresh Basfore of Harijan Busty, Ward No.-33, PS- New Jalpaiguri, Dist- Jalpaiguri (ii) Shankar Mahanto (45) s/o Lt. Sitaram Mahanto of Tinbatti Colony, ward No.-32, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Md. Salman (26) s/o Md. Irfan Ali of Tinbatti Colony, ward No.-32, PS- New Jalpaiguri, Dist.- Japaiguri (iv) Rabi Mitra (30) s/o Lt. Khitish Mitra of Pandu Maligoan, PS- Chalukbari, Dist.- Kamrup, Assam-780012 a/p Ambikanagar, PS-New Jalpaiguri, Dist.- Jalpaiguri and others and arrange for its
