Accordingly I informed to you and as per your direction myself along with force held raid in the said Hotel and found that the owner of the hotel is selling the liquor to customer, then I detained the above noted person and on being pearch said hotel recovered above noted articles. On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain.
