Respected Sir

I Sri Nihar Kanti Nath S/O Late Tegendra Lal Nath as a Land owner of flat who engaged M/s Jupitor, a partnership firm having its office at S.N.T. Godown road, PO & PS Pradhan Nagar, Siliguri represented by its partners (1) Sri Shymal Biswas S/o Late Ranjit Biswas and (2) Smt. Anindita Ghosh Biswas W/o Sri Shymal Biswas both residents S.N.T. Godown road, PO & PS Pradhan Nagar, Siliguri (Phone: 9434021789,9832378940 & 9734242901) would like to share with you some grievances against M/s Jupitor.

I have an agreement with M/s Jupitor as a Land owner to develop our land and constructed a multi stories building and the same was registered as No. 2625/2016 in the office of the ADSR, Siliguri Dist. Darjeeling. Accordingly to the same the Developer has to complete the entire project and handover the possession to us within 24 months from 23.07.2018 (Date of Sanction Plan).

However, till date the developer has not completed the project and there has been delay of more than 35 months. The developers have taken sale consideration from the entire Purchaser and after torturing them for months and months finally only registered their flats (Sri Suraj Lama on March/2022 and Sri Biswajit Das on July 2022 etc.), which were also incomplete in many respects and They had to complete it from their own cost.

The Owners allocated flats were never completed and handed over. The Owners were to take possession of the same in incomplete condition and are in the process completing it with their own money. My elder brother Sri Mrinal Kanti Nath, who is a land owner, also started living in that flat from Jan/2022 in incomplete condition.

I and the purchaser have been mentally harassed and traumatized by the attitude and the behavior of the Developers who pay no heed to our complains. The Developer has already sold out their share of the property and has more or less abandoned the project and we have been made to run from pillar to post with no help. The Developer has stopped taking our calls and when we approach them, they turn violently angry and threaten to hire goons to beat us and use foul and bad words.

In July 2022, I and the purchaser informed Mr. Shymal Biswas in writing to complete the pending works and he assured in written that pending works will complete shortly but so far he has done nothing.

When we asked for electric connection he demanded a huge amount and when we asked him to see the copy of the quotation issued from State Electricity Board, he refused. Without proper electric connection, we are now 6/7 families are in a lot of trouble.

We have tried many places and failed to do anything then I came to you in despair, requesting you to register a criminal complaint against the developer for cheating, fraud, intimidation and breach of trust.
