when my brother (cousin) and Vinod Rai and his
wife along with two (2) small kids visited me
at my matrimonial house to provide me station
as I was running out of food and water. As
my husband along with my in-laws had deliberately
stopped providing me tap water to cook my food.

At first my brother along with his
family was not allowed entry inside the gate
and my husband along with his brother-in-law
Rudra started verbally abusing the to get a

of the house. When I requested them to let the kids inside as they came from far by travelling whole day, Rudra by holding my nephew's hand started pushing him outside. When I came to the rescue of the kid, Rudra snatched my phone and grabbed me ~~in~~ in an unappropriate manner and pulled me towards the balcony and slapped me. He assaulted me physically and his arms hit my breast by causing me immense pain in my breast and my husband was helping him by catching hold of my hands. I shouted for help and that's when my brother came to my help as he was locked outside. With the help of my brother I could finally get my phone but my husband and his brother-in-law tried to break it by throwing it from the balcony, and by brother helped me in getting it back. ~~Then~~ Both, my husband and his brother-in-law continued to verbally abuse me by calling me Rauli and filthy language and started saying that I come from a very low caste and don't deserve to be his wife. I belong to a Scheduled Tribe and for which I'm always abused by my husband and his entire family.

That Mrs. Sanmaya Rai has lodged a false complaint against myself and my brother Shri. Vinod Rai. That all the complaints lodged as FIR in FIR no 292/2023 and FIR no 300/2023 under Bagdogra police station are ~~baseless~~ and false and are put forward to ~~harm~~ harm my image as I have been a victim

All these cases against me are falsely fabricated and the matrimonial house has CCTV installed in all the 3 floors where my physical assault and verbal abuse has also partly been captured and recorded.

That it is my utmost apprehension that I may be killed by Mr. Gyanendra Rai, his brother-in-law Rudra Dey, my father-in-law Bhakta Bahadur Rai, mother-in-law San Maya Rai and sister-in-law Ekina Rai as they have continuously assaulted me in my matrimonial house since 22/06/2023 till today.

So, therefore I humbly request your good self to take necessary steps against my husband Gyanendra Rai his brother-in-law Rudra Dey and my in-laws above named at an earliest.

I shall be ever grateful to you for this act of your kindness.
