Darjeeling That i was went out of station for a week and I authorise my manager cum cashier named DHURUB CHANDRA JAISWAL Son of Bhagwati Prasad Jaiswal, working at Dagapur, Near Darjeeling More, Loknath Mandir, P.S.-Pradhan Naga, Dist. but his mobile number is switch off and could not make any talk then I along with some other staff make search of the said person but not found him and lastly I came to conclusion that the said above named person namely DHURUB CHANDRA JAISWAL, working at Dagapur, Near Darjeeling More, Loknath Mandir, P.S.- Pradhan Nagar, Dist.
