Sub: Road accident involving an E-Scooty, on 08 July 2023 Near Elina Nursing home around 12:15 PM

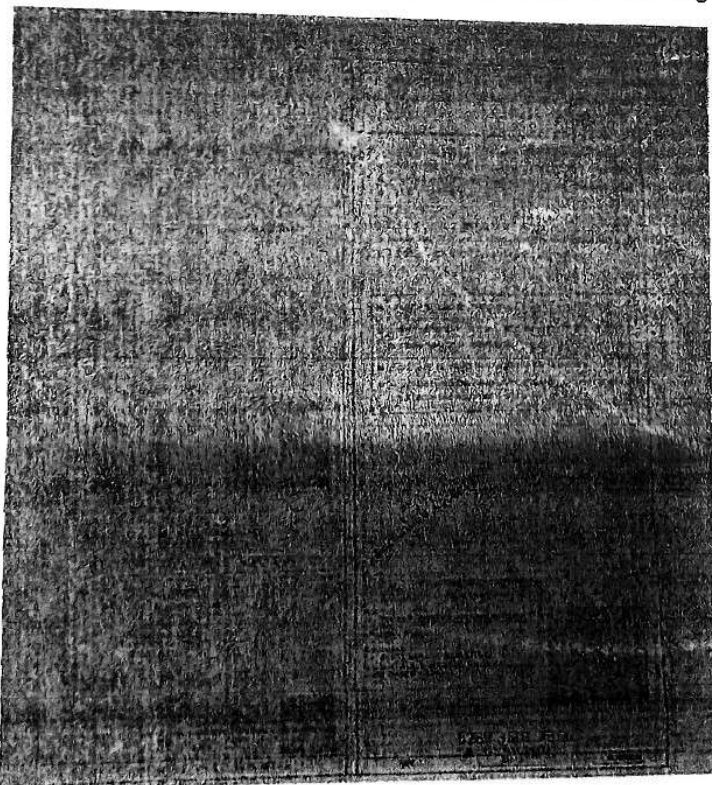
Dear Madam/Sir,

On 8<sup>th</sup> July my younger brother's wife Mrs. Debadrita PaulChoudhury of Satyajit Sarani, Shivmandir was travelling alone in her E-Scooty from her workplace in Sevoke road back home in Shivmandir for lunch.

She met with an accident around 12:15 PM when she came down the flyover near Elina Nursing home. As per people nearby shops and the nursing home she had a collision with a white SUV which was in the service road. After the accident the SUV turned to the left towards Medical college and left the spot.

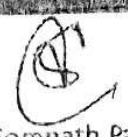
She was given first aid treatment in Elina by locals and both me and my brother was immediately not available. After some time she was rushed to Anandaloke Nursing home by my brother and brothers' acquaintances.

She is admitted in critical care with multiple injuries and is conscious. This is a general complain and I would like the competent authority to check the CCTV footage and take necessary action.
