I, Sri Subhendu Chowdhury, S/O late Shardendu Chowdhury, AE & Station Manager, Shivmandir Customer Care Centre do hereby lodge this complain in favour of Sri Madan Kumar Rai S/o Sri Shage Rai, Vill-Dhimal Jote, P.O- New Rangia, P.S- Bagdogra Dist-Darjeeling, has committed an offence by directly hooking from the LTOH line.

The Details are stated below:-

On 05.07.2023 at about 12.30 pm the undersigned along with Ainal Kabir (J.E-II Shivmandir CCC) and Sonam Sherpa Sr. O.E have inspected the consumer premises (having Con id-401589626) during inspection, it found that the above mentioned consumer having service connection vide con id-401589626 but still consumer was illegally using electricity by way of hooking from LTOH line and enjoyed the assessee load of 1.983 KW. The service line is being disconnected on the spot and the seizure list and inspection report has been prepared in presence of witness named Sri Ramesh Darjee & Sri Md Manirul Islam and acknowledge to the Sri Madan Kumar Rai S/o Sri Shage Rai as a token receipt. The team left the premises at around 1.10 pm on 05.07.2023

The accused person Sri Madan Kumar Rai has committed an offence under section 135(1)(a) of Electricity Act (Amendment) 2007. Hence, you are requested to take necessary action under the law and treated as F.I.R.
